CONSTRUCTION AGREEMENT

THIS AGREEMENT (the "Agreement") made and entered into this <u>26th</u> day of <u>February</u>, 2015, by and between THE CITY OF MAIZE, KANSAS, a municipal corporation (hereinafter the "City"), and <u>Duling Construction Co., Inc.</u>, whose principal office is at <u>4200 So. West St., Wichita, Kansas 67217</u> (hereinafter the "Contractor").

NOW, THEREFORE, for the consideration, covenants and mutual promises hereafter stated, the parties hereto agree as follows:

- **SECTION 1. Contract Documents.** The "Contract Documents" consist of the Agreement and the documents listed in Section 12 of the Agreement (the "Contract Documents"). The documents listed in Section 12 are hereby incorporated by reference herein and are made a part of the Agreement as though they are fully set forth herein.
- **SECTION 2. Work.** The Contractor shall furnish all work as specified or indicated in the Contract Documents. The work to be furnished is generally described as follows:

Water and Sanitary Sewer to serve Maize Industrial Addition

- SECTION 3. The Work The Work shall be done in accordance with the Contract Documents and under the direct supervision of the Engineer, and the Engineer's decision as to the material used in the Work and the method of the Work shall be final and conclusive. In addition, the Contractor shall execute the Work described in the Contract Documents as necessary to produce the results intended by the Contract Documents or reasonably inferable by the Contract to produce the results intended by the Contract Documents.
- **SECTION 4. Contract Time.** (a) The Work under this Agreement shall be substantially completed to the satisfaction of the Engineer within thirty (30) work days after the Notice to Proceed is issued.
- (b) Liquidated Damages. Liquidated Damages for failure to substantially complete the Work in the time period set in this section will be assessed at the amount of \$250 per day.
- **SECTION 5. Contract Sum.** (a) The City shall pay to the Contractor for completion of the Work per unit for quantity in not-to-exceed amounts as set forth in the following chart: See attached bid form.

- (b) Payment. The Contractor shall be entitled to payments of ninety-five percent (95%) of its progress estimated every thirty (30) days during the prosecution of the Work, subject to the Engineer's approval and certification by the City as to progress and completion of the Work. The five percent (5%) retainage, if undisputed, shall be returned no later than the thirtieth (30th)day following substantial completion; however, if any subcontractor is still performing work, the City may withhold that portion of the retainage attributable to such subcontract until not later than thirty (30) days after such work is completed.
- **SECTION 6. Maintenance of Improvements.** The Contractor shall maintain the completed Work for a period of one (1) year from the date of final completion as determined by the Engineer without cost or expense to the City. Such maintenance of the Work shall be done in compliance with the plans and specifications.
- **SECTION 7. Bond.** Before commencement of the Work, the Contractor shall furnish the following bonds:
- (a) A Performance and Maintenance Bond that guarantees the completion of the Work and guarantees maintenance of the Work following Final Completion for a one (1) year period in the amount of Eighty-Eight thousand Three hundred Nine dollars and no/00 (\$88,309.00), conditioned on the satisfactory completion of the Work and completion of guaranteed maintenance of the Work.
- (b) A Statutory Bond of the State of Kansas in the amount of Eighty-Eight thousand Three hundred Nine dollars and no/00 (\$ 88,309.00), conditioned upon the payment of all material and labor bills incurred in the making of the Work.
- (c) The Performance and Maintenance Bond and the Statutory Bond shall comply with requirements set forth in the Standard Specifications.
- **SECTION 8.** Arbitration, Notwithstanding anything to the contrary in the Contract Documents, the City shall not be subject to arbitration and any clause relating to arbitration contained in the Contract Documents herein between the parties shall be null and void and either party shall have the right to litigate any dispute in a court of law.
- **SECTION 9. Assignment.** The Contractor, acting herein by and through its authorized agent, hereby conveys, sells, assigns, and transfers to the City all right, title and interest in and to all causes of action it may now or hereafter acquire under the anti-trust laws of the United States and the State of Kansas, relating to the particular product, products or services purchased or acquired by the City pursuant to this Agreement.
- **SECTION 10. Deferment or Cancellation of Agreement.** The Agreement may be deferred or cancelled by the City in accordance with the Standard Specifications.
- **SECTION 11. Contractor Representations.** (a) The Contractor has familiarized itself with the nature and extent of the Contract Documents, the Work, the site, locality, and all local conditions and laws and regulations that in any manner may affect cost, progress, performance, or furnishing of the Work.
- (b) The Contractor has studied carefully all physical conditions which are identified on the Plans.
- (c) The Contractor has the responsibility to satisfy himself as to any explorations, subsurface tests, reports, or investigations of the subsurface or physical conditions at or contiguous to the site as otherwise may affect the cost, progress, performance or furnishing of the Work as the Contractor considers necessary for the performance or furnishing of the Work at the Contract Price, within the Contract Time and in accordance with the other terms and conditions of the Contract Documents.

(d) The Contractor has given the Engineer written notice of all conflicts, errors or discrepancies that it has discovered in the Contract Documents and the written resolution thereof by the Engineer is acceptable to the Contractor.

SECTION 12. Contract Documents. The Contract Documents which comprise the entire Agreement between the City and the Contractor concerning the Work consist of the following:

- (a) this Agreement;
- (b) Construction Plans;
- (c) Proposal Form;
- (d) Performance Bond;
- (e) Statutory Bond;
- (f) The City of Wichita Standard Specifications for Construction of City Projects, 1998 Edition (the "Standard Specifications"), a copy of which is on file with the City Clerk's office of the City; provided that, for purposes of this Agreement, references to "Wichita" in the Standard Specifications shall be replaced with "Maize" and references to addresses in the Standard Specifications that refer to a City of Wichita address shall be replaced with "10100 Grady Avenue, Maize, Kansas 67101."

SECTION 13. Governing Law. The Contract and Contract Documents shall be governed by the laws of the State of Kansas.

SECTION 14. Miscellaneous Provisions. (a) If there is a conflict, the terms and conditions in the Standard Specifications shall prevail over terms and conditions of the Agreement.

- (b) No assignment by a party hereto of any rights under or interests in the Contract Documents will be binding on another party hereto without the written consent of the party sought to be bound; and specifically but without limitation, monies that may become due and monies that are due may not be assigned without such consent (except to the extent that the effect of this restriction may be limited by law), and unless specifically stated to the contrary in any written consent to an assignment, no assignment will release or discharge the assignor from any duty or responsibility under the Contract Documents.

Currently Casey's General store is the only fuel station that does not require pre-payment for fuel. It is their corporate policy. Because of this, gas run offs are a common occurrence. Adopting a pre pay ordinance will elevate this problem. Casey's General store management are supportive of the ordinance.

FINANCIAL CONSIDERATIONS: None

<u>LEGAL CONSIDERATIONS:</u> This amended ordinance has been reviewed by staff and drafted and approved by legal.

<u>RECOMMENDED ACTION:</u> Create an ordinance requiring the pre-payment or pre-approval prior to activation or discharge of any fuel.

AN ORDINANCE OF THE CITY OF MAIZE, KANSAS, CREATING ARTICLE 3 OF CHAPTER 5 OF THE CODE OF THE CITY OF MAIZE, KANSAS, RELATING TO REQUIRING BUSINESS ESTABLISHMENTS AND PERSONS EMPLOYED BY BUSINESS ESTABLISHMENTS THAT SELL GASOLINE AND/OR DIESEL FUEL TO REQUIRE PRE-PAYMENT OR PRE-APPROVAL OF SALES OF GASOLINE AND/OR DIESEL FUEL.

BE IT ORDAINED by the Governing Body of the City of Maize, Kansas:

SECTION 1. Article 3 of Chapter 5 of the Code Created. Article 3 of Chapter 5 of the Code of the City of Maize, Kansas, is hereby created and will read as follows:

Article 3. PRE-APPROVAL OR PRE-PAYMENT OF GASOLINE/DIESEL FUEL.

- 5-301. DEFINITIONS. As used in this article, the following terms shall have the meanings given in this section:
 - (1) "Pre-approval" means the business establishment and/or persons employed by the business establishment have issued an identification card to the purchaser that verifies and records the purchaser's driver's license information and that allows the purchaser to dispense gasoline or diesel fuel in advance of payment.
 - (2) "Pre-payment" means payment in advance for any quantity of gasoline or diesel fuel sold at any time by cash, credit card, debit card, check or any other legal means.
- 5-302. GASOLINE PRE-PAYMENT OR PRE-APPROVAL. Business establishments and persons who are employed by business establishments that sell gasoline and/or diesel fuel shall require prepayment or pre-approval of the sale of gasoline and/or diesel fuel prior to activation or authorization to dispense gasoline or diesel fuel through a fuel dispensing unit or fuel pumping device.
- 5-303. PENALTY. It is unlawful for any person to violate the provisions of Section 5-302 of the Code of the City of Maize, Kansas. The penalty for violation of Section 5-302 shall be a fine that does not exceed five hundred dollars (\$500) plus court costs.

SECTION 2. Effective Date. This ordinance shall be effective upon the publication of a summary of the ordinance in the official city newspaper.

BACKGROUND:

Council directed staff to find a company to review our pay and compensation plan for City Employees.

Staff contacted Austin Peters Group (Overland Park), Evergreen (Florida) and Waters Consulting Group (Texas). Both Austin Peters and Evergreen responded to our request for information. Evergreen bid the project at \$18,000 and Austin Peters bid \$7,800. Waters did not submit a bid. Staff contacted Waters Consulting twice to ensure they were not interested in the job.

FINANCIAL CONSIDERATIONS:

The cost of the study totals \$7,800 with a deposit of \$3,900 after the letter of agreement is signed and they invoice the city.

LEGAL CONSIDERATIONS:

The City attorney has reviewed the Letter of Understanding and has approved it as to form.

RECOMMENDATION/ACTION:

Authorize the Letter of Understanding for the Compensation study with the Austin Peters Group and authorize the Mayor to sign.

Letter of Understanding

LETTER OF UNDERSTANDING COMPENSATION STUDY

This letter shall serve as a letter of agreement the City of Maize of Maize, Kansas and The Austin Peters Group, Inc. of Overland Park, Kansas, governing the provision of professional human resource consulting for the City of Maize.

The Austin Peters Group, Inc. shall provide consulting services to gather salary and benefits data for a peer group of cities and similar organizations to the City of Maize as described in the proposal dated March 3, 2015. This agreement's obligations and benefits shall apply to any successor companies.

The City of Maize agrees to compensate The Austin Peters Group, Inc. under the terms and conditions as provided herein.

Total project payment is not to exceed \$7,800.00 for services related to a compensation study. The market data collected will be range minimums, range maximums, actual pay. Payments are due upon receipt of invoices by the City of Maize and will be invoiced in 2 payments according to progress of the study with a deposit of \$3,900.00.

With regard to the services to be performed by The Austin Peters Group, Inc. pursuant to the terms of the agreement, The Austin Peters Group, Inc. shall not be liable to the City of Maize, or to anyone who may claim any right due to his relationship with the City of Maize, for any acts or omissions in the performance of said services on the part of The Austin Peters Group, Inc. or on the part of the agents or employees of The Austin Peters Group, Inc.; except when said acts or omissions of The Austin Peters Group, Inc. are due to their negligence or willful misconduct. The City of Maize shall hold The Austin Peters Group, Inc. free and harmless from any obligations, costs, claims, judgments, attorneys' fees and attachments arising from or growing out of the services rendered to the City of Maize pursuant to the terms of this agreement or in any way connected with the rendering of said services, except when the same shall arise due to the negligence or willful misconduct as determined by a court of competent jurisdiction.

Both parties to this Agreement, agree that the liability of the other party, its officers, agents, employees, and contractors, regardless of the legal theory under which such liability is imposed, shall not exceed the total fee paid to Austin Peters Group for the analysis or recommendations or other associated services that gave rise to the claim being asserted by the City of Maize or by Austin Peters Group, Inc.. In no event shall either party to this Agreement, its officers, agents, employees and contractors, be liable for any special, incidental or consequential damages.

If any provision of this Agreement is deemed to be invalid or inoperative for any reason, that part shall be deemed modified to the extent necessary to make it valid and

operative, or if it cannot be so modified, then severed, and the remainder of the Agreement shall continue in full force and effect as if the Agreement had been signed with the invalid portion so modified or eliminated.

Additionally, the ordinance outlines the appeal process. The first appeal will go through the City Administrator. Failing satisfaction at that level, the City Council would receive the appeal.

As with most building ordinances, this places a focus on safety, which is the reason staff recommends Council adopt this ordinance.

BE IT ORDAINED by the Governing Body of the City of Maize, Kansas:

SECTION 1. Article 6 of Chapter 4 of the Code Created. Article 6 of Chapter 4 of the Code of the City of Maize, Kansas, is hereby created and will read as follows:

Article 6. International Property Maintenance Code.

- 4-601. ADOPTION OF 2012 INTERNATIONAL PROPERTY MAINTENANCE CODE. The International Property Maintenance Code, 2012 edition, hereafter referred to as the "IPM Code" is adopted in its entirety by the governing body of the City of Maize, Kansas (the "City"), as the code of the City for purposes of regulating and governing the conditions and maintenance of all property, buildings and structures; by providing the standards for supplied utilities and facilities and other physical things and conditions essential to ensure that structures are safe, sanitary and fit for occupation and use. At least one copy of the IPM Code shall be marked or stamped "Official Copy as Incorporated by Ordinance No. ____," with all sections or portions thereof intended to be omitted clearly marked to show any such omission or to show the section. article, chapter, parts or portions that are incorporated, as the case may be, and to which shall be attached a copy of the incorporating ordinance, and filed with the city clerk to be open to inspection and available to the public at all reasonable business hours. The police department, municipal court judge and all administrative departments of the City charged with enforcement of the IPM Code will be supplied, at the cost of the City, such number of official copies of the IPM Code as may be deemed expedient.
- 4-602. CHANGES TO THE IPM CODE. (a) Section 103 of the IPM Code is omitted and the following language is inserted in its place:

"The City Administrator or other City employee as designated by the City Administrator shall serve as the "Code Official" of the IPM Code."

(b) Section 202 General Definitions is changed by adding to the General Definitions the following definitions:

"CITY ADMINISTRATOR. The City Administrator for the City. CITY. The City of Maize, Kansas.

BOARD OF APPEAL. The governing body of the City."

- (c) Section 108 Unsafe Structures and Equipment is omitted and the following language is inserted in its place:
 - "108.1 General. When a structure is found by the Code Official to be unsafe, or when a structure is found unfit for human occupancy, or is found unlawful, such structure shall be condemned pursuant to the provisions of Article 5 of Chapter 4 of the Code of the City and/or by powers granted by K.S.A. 12-1750 through 12-1756 as may be amended from time to time."
- (d) Section 111.3 Notice of Meeting is omitted and the following language is inserted in its place:
 - "111.3 Notice of Meeting. The Board of Appeal shall meet within sixty (60) days of the filing of an appeal."
- (e) Section 111.6.1 Records and Copies is omitted and the following language is inserted in its place:
 - "111.6.1 Board Records. The Board shall modify or reverse the decision of the Code Official only by a concurring vote of a majority of the City Council present at the meeting. A majority of a quorum of City Council members must be present for a hearing to be conducted. The Mayor shall cast the deciding vote in case of a tie vote by the City Council.

Staff has received multiple requests to house chickens and rabbits in their backyards. The Planning Administrator has allowed chickens and rabbits with the intent that the Code would be modified to reflect the decision. This change in the code via ordinance would allow 12 rabbits and 8 fowl (no roosters) on lots less than 1 acre. The rest of the code remains basically unchanged.

ORDINANCE NO. ____

AN ORDINANCE OF THE CITY OF MAIZE, KANSAS, AMENDING SECTION 2-401 OF THE CODE OF THE CITY OF MAIZE, KANSAS, THAT RELATES TO OTHER ANIMALS/DANGEROUS ANIMALS/ DOMESTIC ANIMALS, AND REPEALING THE ORIGINAL SECTION 2-401 OF THE CODE OF THE CITY OF MAIZE, KANSAS.

BE IT ORDAINED by the Governing Body of the City of Maize, Kansas:

SECTION 1. <u>Section 2-401 Amended</u>. Section 2-401 of the Code of the City of Maize, Kansas, is amended to read as follows:

- 2-401. UNLAWFUL KEEPING OF ANIMALS. It shall be unlawful for any person to keep, harbor, own or in any way possess within the corporate limits of the city:
 - (a) on premises of less than one (1) acre of contiguous land area: any horse, donkey, mule or other equine; sheep; goat; swine; cow, ox or other bovine; or large ratite:
 - (1) not more than one of the animals listed at Section 2-401(a) may be kept, harbored, owned or in any way possessed on premises that are between one acre of contiguous gross land area and less than two (2) acres of contiguous land area;
 - (2) one (1) additional animal per acre, above the number allowed in Section 2-401(a)(1) of the animals listed Section 2-401(a), may be kept, harbored, owned or possessed on premises that consist of contiguous land area that is two (2) acres or larger; i.e., two of the above listed animals on two acres or more, three on three acres or more, four on four acres or more, etc.
 - (b) Roosters (male chickens), guinea cocks, peacocks or other birds that by nature exhibit loud calls:
 - (c) More than two (12) rabbits or more than three (8) fowl on any one (1) premises;
 - (d) Any warm-blooded, carnivorous or omnivorous, wild or exotic animal (including but not limited to non-human primates such as apes, chimpanzees, gibbons, gorillas, orangutans, siamangs, and baboons, as well as bears, bison, bobcats, cheetahs, crocodilians, constrictor snakes, coyotes, deer, white-tailed deer, elk, antelope, moose, elephants, game cocks or other fighting birds, hippopotami, hyenas, jaguars, leopards, lions, lynxes, monkeys, ostriches, pumas, cougars, mountain lions, panthers, raccoons, rhinoceroses, skunks, tigers, foxes and wolves; but excluding ferrets and small rodents of varieties used for laboratory purposes).
 - (e) Any mammal, amphibian, fish, reptile or fowl which is of a species which, due to size, vicious nature or other characteristics would constitute a danger to human life, physical well-being, or property, including but not limited to snakes which are venomous or otherwise present a risk of serious physical harm or death to human beings as a result of their nature or physical makeup including, but not limited to, boa constrictors, Madagascar ground boas, green and yellow anacondas, Cuban boas, Indian pythons, reticulated pythons, African rock pythons, Amethystine pythons, Boelens pythons and all members of the family *pythonidae* that exceed six (6) feet in length.
- (f) Any dog or cat having a disposition or propensity to attack or bite any person City of Maize, Orangimal without provocation is hereby, defined as a dangerous animal. For the

purposes of this chapter, where the official records of animal control and/or the police department indicate a dog or cat has bitten any person or persons, it shall be prima facie evidence that the dog or cat is a dangerous animal.

- (g) Any animal having poisonous bites including rear-fang snakes.
- (h) Any pit bull dog; provided, that pit bull dogs registered with the city on the date of publication of this article may be kept within the city subject to the standards and requirements set forth in section 2-403 immediately hereafter. <u>Pit bull dog</u> is defined to mean:
 - (1) The Staffordshire bull terrier breed of dog;
 - (2) The American pit bull terrier breed of dog;
 - (3) The American Staffordshire terrier breed of dog;
- (4) Any dog which has the appearance and characteristics of being predominantly of the breeds of Staffordshire bull terrier, American pit bull terrier, American Staffordshire terrier; or a combination of any of these breeds.

The registration of a dog at any time in any jurisdiction as a pit bull or any of the dogs listed above shall constitute *prima facie* evidence the animal is prohibited by this section.

(i) Any domesticated dog that has in its known genetic history and/or formal pedigree crossbreeding with the wolf species to include, but not be limited to, animals referred to as wolf-hybrids or wolf-mix breeds or the breed known as Tundra Shepherd. The registration of an animal at any time in any jurisdiction as a wolf-hybrid, wolf-mix or Tundra Shepherd shall constitute *prima facie* evidence the animal is prohibited by this section. For the purposes of this section all references to animals described herein shall be to wolf-hybrids.

SECTION 2. Repeal. The existing Section 2-401 of the Code of the City of Maize, Kansas, is hereby repealed.

SECTION 3. Effective Date. This ordinance shall take effect and be in full force and effect from and after its passage, approval and publication of a summary one time in the official City newspaper.

ITEM: Intern Position

BACKGROUND:

The student intern program has been a part of Maize administrative operations for several years. In the past it was a combination of two interns, one a University intern and the other a High School intern. Due to lack of funding from the university, about twelve years ago or so, the funding for the university intern position was phased out.

After this position was phased out, the City attempted to keep two interns by utilizing high school interns and on a rotating base. This actually worked quite well. The Council was aware that the second intern position was never an official part of the organization chart after the university intern was removed.

Part-time HS interns have proven to be extremely helpful. They can perform a variety of duties and make a valuable contribution to city staff. In addition, it's personally helpful to the intern, thus allowing the city to make a positive contribution in a young person's life.

Since September 2012 we have been working with one HS intern only. Now some two & a half years later it's clear that the city would be better served with the latitude of having two HS interns in the organization.

Our current intern, Kristen Jones, was hired in June 2014. She, like those before her, is capable of conducting many of the front desk responsibilities thus allowing full-time employees to assist with other city business. She is also helpful during vacations of full-time employees and can assist with some special city projects.

Due to school and personal schedule Kristen, like previous interns, can only work a limited number of hours during the week. Currently she averages about 6-8 hours per week. A second intern could be scheduled to work at times when Kristen is not available and probably for about the same number of hours.

FINANCIAL CONSIDERATIONS:

High School interns are part-time and receive no benefits.

The hourly pay range is \$7.58 to \$9.75.

For the second half of 2014 our current intern earned \$2,800.

Year to date her total 2015 salary earned has been \$434.

Funding a second HS intern position is minimal and can be funded from existing funds.

The impact on the budget is negligible.

The following is a summary intended to keep the Council apprised of the status of ongoing planning projects.

- Commercial development at the northeast corner of 37th & Maize the corner lot has been purchased for future development as a financial institution. The lot immediately north of the corner is also under contract for commercial development. I continue to work with the property owners to address issues of access along Maize Road and future construction of a right turn lane along these properties. A vacation of complete access control petition in front of several of the lots along Maize Road has been filed and will be heard by the Planning Commission on April 2nd.
- 2. Southeast corner of 119th and 53rd Street North the property owner requested a zone change to Limited Commercial for approximately 1.6 acres on the hard corner for future commercial development. The Planning Commission reviewed this case at their March 5th meeting and recommended unanimously to deny the request. The applicant has since withdrawn their application.
- 3. Zone change request at 9100 W 61st Street the property owner has submitted a request for a zone change to allow horse stables and boarding at this location. The Planning Commission will review this request at their April meeting.
- 4. Conditional Use request to enlarge an existing sand extraction operation at 5800 N. Ridge Road. The Planning Commission will review this case at their April 2nd meeting.
- 5. General planning issues I continue to meet, both on the phone and in person, with citizens and developer's representatives requesting information on general planning matters, such as what neighboring property owners are planning to do, what they are allowed to do on their property, and what the process is for submitting various applications and materials to the Planning Commission.

RE: March Report

1) Public Works Facility

Staff met again on 3/10/15 with Bill Johnson, President of Evens Building Company. A final drawing concept and cost projection of the proposed new facility will be forthcoming shortly. Plans for electronics, furniture and security are also being considered. Staff visited and toured a similar building, as has Karen. If other Council members have interest in a tour it can be arranged. If all goes as planned, staff's goal is to have this to the Council for consideration next month.

2) Splash Park/Restrooms @ Maize Park

The Park & Tree Board met last evening to discuss several items. They approved and will recommend to the Council purchasing the Splash Park design from "Power Play." Other venders were considered. They deferred action on a new restroom facility recommendation until additional bids can be considered. They also approved an updated CIP plan for Council consideration during the 2016 budget process.

A \$1000 grant from South Central KS Prosperity group was discussed. This money has to be used to purchase native grasses & trees for landscaping projects. The Board accepted a staff recommendation to utilize this for additional landscaping improvements north of City Hall.

3) 37th Street Improvement

Wichita, Sedgwick County have agreed to join with us on the improvement for 37th Street. The County is drawing up a joint agreement. The schedule for the improvement is being worked out.

4) Coffee with Carolyn (McGinn)

State Senator Carolyn McGinn will be having an informal, open to the public, meeting here at City Hall on April 14th @ 10am. The discussion will focus on the current legislative session.

5) Municipal Leadership Academy

The KS League of Municipalities is scheduled to conduct a Municipal Leadership class on budget and finance at Maize City Hall (conference room) on March 14th @ 10am. Becky has agreed to be a co-presenter. At this time only five people have signed up. There is a possibility it could be canceled.
