EAGLE'S NEST POND REVISIONS:

Brent Wooten, of Baughman Company, presented options to improve the drainage of water from the Eagle's Nest detention pond. Discussion followed. No action was taken.

MYSTIC LAKES PAVING REPORT:

Richard Mfulco, of Andale Ready Mix Central, presented the results of the street improvement project in Mystic Lakes to the Council. Discussion followed. No action was taken.
