APPROVAL OF AGENDA:

The Agenda was submitted for Council approval.

CONSENT AGENDA:

The Consent Agenda was submitted for approval including the Disbursement Report of checks #53512 through #53650 in the amount of \$272,669.75; the Council Minutes of November 21, 2011 and December 12, 2011 for approval; the Planning Commission minutes of November 3, 2011 and the Tree & Park Board Minutes of November 8, 2011 for receipt and file. For approval, 2012 Cereal Malt Beverage applications from Maize Pizza Hut North, Maize Pizza Hut Italian Bistro, Kwik Shop and Kansas International Dragway and Busby Ford & Reimer, LLC Auditing Contract for year ended December 31, 2011 in the amount of \$13,380.

to sign.

MAIZE PARK CEMETERY PLAT:

A plat for the second phase of the Maize Cemetery was submitted for Council approval.

MOTION: Clasen moved to accept the Second Addition to Maize Cemetery final plat with

accompanying dedications, with plat to be filed with the County Register of Deeds and

authorize the Mayor to sign.

Fitzmier seconded. Motion declared carried.

ZONE CHANGE AT 319 S. PARK (Z-03-11)

A request for a zone change from SF-5 Single Family Residential to NR Neighborhood Retail at 319 S. Park Street was submitted for Council approval.

MOTION: *McCreath* moved to approve and adopt the ordinance for a zone change within Maize

city limits.

Stivers seconded. Motion declared carried.

City Clerk assigned Ordinance #844.

LEJAY PROPERTY ZONE CHANGE:

A request for a zone change from SF-5 Single Family Residential to MF-18 Multi-Family and LC Limited Commercial for property located at 119th Street and 37th Street was submitted for Council approval.

MOTION: *Reid* moved to table the item until the January 16th, 2012 regular Council meeting.

McCreath seconded. Motion declared carried 4-1 with Clasen voting No.

COURT AND UTILITY COLLECTIONS:

Agreements with Kansas Counselors, Inc. to collect outstanding debts for the Municipal Court and City Utilities were submitted for Council approval.

MOTION: *Clasen* moved to approve the Kansas Counselors, Inc. collection agreements and

authorize the Mayor to sign.

Stivers seconded. Motion declared carried.

COMMERCIAL ECONOMIC DEVELOPMENT GRANT INCENTIVE PLAN:

The 2011/2012 Commercial Incentive Plan was submitted for Council approval. The plan allows grants to qualifying new businesses in Maize to promote economic development in the City.

MOTION: *Clasen* moved to adopt the Home Rule Ordinance approving the 2011/2012 Commercial

Incentive Plan and authorizing the issuance of general obligation bonds to fund the grants

authorized by such Commercial Incentive Plan. *Stivers* seconded. Motion declared carried.

City Clerk assigned Ordinance #845.

EXECUTIVE SESSION:

MOTION: Clasen moved to continue the City Attorney's contract with an open-ended term and an

annual salary of \$40,000 effective January 1, 2012.
