MOTION: *Reid* moved to approve the special assessment ordinance with the following change: - Watercress Village 2nd Addition Phase 1 to have 20-year special assessments. *Clasen* seconded. Motion declared carried.

CENTRAL STREET PROJECT AMENDING AUTHORIZATION RESOLUTION:

A resolution authorizing the financing of the Central Street Project was submitted for Council approval.

MOTION: *Clasen* moved to approve the amending resolution authorizing the financing of improvements to Central Street in a total amount not to exceed \$360,000 and authorize the Mayor to sign. *McCreath* seconded. Motion declared carried.

City Clerk assigned Resolution #522-13.

CENTRAL STREET CONSTRUCTION BIDS AND CONTRACT:

Construction bids and contract for the Central Street Project were submitted for Council approval.

MOTION: *Stivers* moved to accept the low bid and approved the construction agreement with Cornejo & Sons in an amount not to exceed \$314,745.98 and authorize the Mayor to sign. *McCreath* seconded. Motion declared carried.

TRANSYSTEMS INC. CENTRAL STREET INSPECTION AGREEMENT:

A supplemental engineering contract with TranSystems for construction inspection services for the Central Street Project was submitted for Council approval.

MOTION: *Stivers* moved to approve the TranSystems supplemental agreement in an amount not to exceed \$20,269.08 and authorize the Mayor to sign. *McCreath* seconded. Motion declared carried.

ZONE CHANGE FROM SF-5 SINGLE FAMILY RESIDENTIAL TO OW OFFICE WAREHOUSE (Z-02-012):

An ordinance for a zone change from SF-5 Single Family Residential to OW Office Warehouse for the property located at 6099 N. Ridge Road was submitted for Council approval.

MOTION: *Clasen* moved to approve and adopt the ordinance for zone change within Maize city limits for Johnson Legacy Landscapes. *Reid* seconded. Motion declared carried.

City Clerk assigned Ordinance #861.

20-YEAR SPECIAL ASSESSMENT REVIEW – WATERCRESS VILLAGE 2ND ADDITION:

A request for 20-year special assessments in Watercress Village 2nd Addition Phases 2-4 was submitted for Council approval.

MOTION: *Fitzmier* moved to approve the granting of 20-year special assessments for Watercress Village 2nd Addition Phases 2-4. *Stivers* seconded. Motion declared carried.
