### **Tree Planting:**

#### CIP:

**Detention Pond east of City Hall:** The Board discussed the current condition of the pond and wondered what improvements were needed. Members discussed the possibility of installing rock for the time being and making the remaining improvements at a later date. The board also decided to look at the pond upon the conclusion of the meeting.

**Irrigation at the City Park:** Discussion centered on what areas of the park should be irrigated. The current thought is to have irrigation from Central, along Khedive, to the Play area, over to the parking area, finishing back at the intersection of Central and Khedive. The Board would like to get further input from Ron regarding the matter. The Board also discussed if a well would be needed and how to go about getting RFPs.

Water Play Plaza: The Board discussed the importance of RFPs in this case. Location within the park is also an important factor that was discussed. However, a final location was not picked.

**Trees:** The Board would like to focus right now on the trees at the City Hall property.

### **Time Change:**

Fearey mentioned that Mondays or Thursdays would work best for her schedule.

**MOTION: B. Pew** moved to temporarily change the meeting date to the 2<sup>nd</sup> Thursday

of the month at 7:00pm starting in September through the end of the year.
