#### **APPROVAL OF AGENDA:**

#### MONARCH BUTTERFLY WAYSTATION

Staff requested date suggestions to implement the Monarch Butterfly Waystation project. Maize is in the migratory flight path of monarch butterflies – a species nearing endangerment status. This nationwide project requires locating a public space that can be planted with monarch butterfly friendly plants such as milkweed and coneflowers. Maize would then be noted officially on a nationwide register.

**MOTION:** Scarpelli moved to table a decision and direct staff to research more land options

for consideration.

#### ELECTION OF PARK AND TREE BOARD SECRETARY

With the retirement of Mike Burks from the Board, election of a new Secretary was held.

**MOTION:** *Atchison* moved to appoint Marina Fulton as the Secretary.

#### **ARBOR DAY 2016**

In recognition of the work done at the cemetery and the 125<sup>th</sup> anniversary of the City of Maize, staff recommends hosting a reception at the Cemetery to honor representatives of the City's founding families, planting trees to reforest the Cemetery, and holding a tree planting demonstration. The cost of the reception, trees and labor is not to exceed \$1500. The celebration will be moved to the Saturday following Arbor Day: April 30<sup>th</sup>, 2016. Time will be determined at a later date.

**MOTION:** *Scarpelli* moved to approve plans to host an Arbor Day celebration at the

Cemetery on Saturday, April 30<sup>th</sup>, 2016 with costs not to exceed \$1500.

Wardell seconded. Motion declared carried.
